

## **Decision of the attestation commission**

The fate of every student-contract student who has expressed a desire to study for free is decided by a special commission, which is meeting on this issue.

It can take a long time to solve the dilemma, but in the final solution the following sequence takes place:

1. In the first place are excellent students who, by their labor, have earned such a profitable financial incentive.
2. The second place is occupied by students of preferential categories, where at first preference is given to orphans, then to disabled children and students who were orphaned during their studies.
3. In third place are activists, ardent unionists who have also made a significant contribution to the development and prosperity of their native university.

The rest of the categories of students, as a rule, are not considered, because the transition to a free form of education is an encouragement, a prize for work, a reward for efforts. There will definitely not be a freebie.

By the way, there is also a downside to the coin, when a state employee is expelled for poor academic performance or systematic violation of the statute of the university, offering a new form of education - on a contract basis.

There are already fewer applicants here, so former students prefer to urgently leave the walls of their once beloved university.

Tips for all students:

1. As mentioned above, the lists of budget vacancies are published on the official website of the faculty or directly on the information board at the dean's office.

If the employees of the dean's office hide such information, then the student should know that the number of vacant places is determined at the beginning of the academic year and after the winter session.

In the first case, the number of places available by the university and the number of applicants is taken into account (we are interested in the difference between these two values).

In the second case, the number of students expelled for academic failure is determined and, accordingly, the number of vacated budget places. So you can calculate your chances yourself, and then contact the dean's office with a typical question.

2. The official application has an established sample, which can be found in the dean's office. The heading indicates the coordinates of the rector, and the content - the essence and arguments in favor of your wish.

The application should not only be accepted, but also assigned a special number, and then sent for consideration to the administration.

As a rule, this is a question of not a single day, so you should not panic and wind yourself up with anxious thoughts during a period of painful waiting.

If the application is not written before a certain period of time, then the student's period for a free form of study is postponed for at least one semester.

3. If there are no free places in a specific specialty, but the student is studying approximately, then it will not be possible to transfer him to the budget. You will have to wait for vacancies or apply for a transfer to another institution of higher education with lower ratings.

A line is gradually gathering, where students of the preferential category are already clearly one step ahead.

Now everyone understands what the subtleties of such a transition are. All that remains is to give useful advice: if you got a contract, but at the same time you study well, it is enough to spend generic money, and in considerable amounts.

Conclusion: It's time to set the goal of translation, and for this, the first thing to do is to appear at your dean's office with a characteristic question. Then it's a matter of time, knowledge, opportunities and, of course, the availability of vacancies for state employees at the faculty. "
